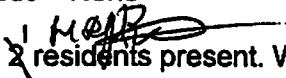
17/50 Minutes of previous closed meeting 15th May 2017 These were approved and signed.

17/51 Minutes of previous open meeting 15th May 2017 These were approved and signed.

17/52 Matters arising – The councillors were advised of the responses to the planning applications.

Pathway Signs – the clerk contacted CC and was advised that some signs had been given to Cllr. Paynter but more would be sent. Cllr. Paynter said that he had put up some of these but had not done so in the woodland area.

17/53 Declarations of interest - None

17/54 Public Participation -  residents present. Ward Cllr. Paynter spoke of the future Network meeting and hoped that someone would be able to attend as some of the things to be discussed could affect the local school. This is because of the new school proposed at Hay Common could take pupils away from Werrington who currently have over spill.

17/55 Neighbourhood Plan update. The steering group meeting to take place the following Wednesday. Finalising all needed to prepare for submission to CC.


17/56 Co option to fill position for new councillor – there were two applications. Mrs S. Craig and Mr Paul Callow. All councillors had received and reviewed the applications before the meeting. Cllr. Wilton spoke on behalf of Mrs Samantha Craig. Although absent, Cllr. Walters had given her vote to the clerk. A vote was taken and Mrs S. Craig was co opted onto the council 5-1. At this point Councillor Dennis proposed that he would be resigning from the council as he thought it a good idea to have all individuals interested in becoming involved in the council the chance to take part. A formal resignation would be offered and Mr Paul Callow to be offered the opportunity to become a councillor at the next meeting.
