**Apologies** Cllr. Peter Hawke,

**17/01 Minutes of previous meeting 12<sup>th</sup> December 2016** These were approved and signed after the clerk brought to the meetings attention the omission of the apologies from the Ward Councillor Mr Adam Paynter.

**17/02 Matters arising** – Highways had been contacted regarding the road marking at the bridge at Yeolmbridge. No response had been received as yet.

**17/03 Declarations of interest** None declared

**17/04 Public Participation** – None present at the meeting.

**17/05 Neighbourhood Plan** The clerk reported that the group were due to meet with Emma Ball from Cornwall Council on the 18<sup>th</sup> January. The meeting was to go through all documentation so far.

**17/06 CRHA** Communication had been received from Peter Moore (CRHA). As new funding was now available for housing and having been involved with the steering group for the Neighbourhood Plan, he wished to come to discuss the situation with the Parish Council. It was agreed to invite him to either the February or March meeting. The discussion would take place before the main meeting.

**17/07 Mowers** Cllr. Dennis suggested that as volunteers now mow the green in Yeolmbridge it might be advisable that the council think about either buying a new mower for the new season or refurbishing the old one. All the councillors were in favour of getting prices for a new mower. Research as to prices and where to purchase the mower was to be done by Cllr. Dennis ready for the next meeting.

**17/08 Report on Planning Meeting (Dec. 15<sup>th</sup>)** attended by Cllr. Price. An interesting meeting with much discussion of the way the Cornwall Local Plan affects neighbourhood plans. Full report to be handed to clerk.

**17/09 Report on Network Meeting (Dec15th)** attended by Cllr. Dennis. Notes for this meeting have already been sent to the councillors. In addition Cllr. Dennis reported that Cllr. N. Burden had impressed the need that the Launceston Hospital must be kept open, and also that in regard to policing, no further cuts to police numbers were to be made.
